CIRCULAR

Sub: Exercising of option for deduction of tax at source under Old or New Regime for the Financial Year 2024-25(A.Y. 2025-26).

As per the provisions of the Income Tax Act, 1961, any income chargeable under the Head "SALARY" is subject to deduction of Income Tax at Source at the rate appropriate to the estimated salary of the relevant year. Further, the orders on the subject stipulate that tax should be deducted proportionately by the Drawing & Disbursing Officer.

A new tax regime has been inserted in the Income Tax Act, 1961, which provides that a person being an individual having income other than 'Income from business or profession', may opt to pay tax from the financial year 2020-21 onwards either as per old tax regime or new tax regime, whichever is beneficial.

Therefore, all officers/officials drawing salary from RGSSH are requested to exercise their option, in the Proforma enclosed in Annexure-A for the financial year 2024-25 (AY 2025-26) for the purpose of monthly income tax deduction from pay and allowances. The requisite information may be reached to **DDO (RGSSH) latest by 31.07.2024.**

In case, no option is received by the stipulated date, it will be presumed that the officer/official is opting for the New Regime structure and savings according to PBR (Pay Bill Register) will be taken into account for necessary deduction of Income Tax from the salary of the employee concerned.
